If a prize has a value of \$600 or more and the prize value is more than 300 times the stake (ticket price), certain Internal Revenue Service (IRS) requirements must be met. Please contact the Accounting Manager, 355-5000, if you are awarding a prize worth \$600 or more to arrange the logistics of the federal tax return, including: When the prize is awarded, you must obtain a W-9 form from the award winner along with the winning driver's license number and the state that issued the license. This information is used to report game winnings to the IRS. If the prize is \$5,000 or more, MSU may be required to collect the withholding tax from the prize winner. In general, federal withholding tax from the prize winner are 24% with a W-9 completed (31.58% for some non-cash payments). The withholding tax rate in the State of Michigan is 4.25%. If any of the lottery prize donated, they should be reported to University Advancement will require you to fill out a lottery prize donated. University Advancement uses this information to formally acknowledge donations from donors if they meet certain requirements. Information about the prize is valued at or above \$600. Unrelated Business Income Tax Requirements If a unit holds more than one lottery each year, the IRS may claim federal unrelated business income tax (UBIT) on the net income of the business. In order to meet the federal exclusion for UBIT on charity games, the unit is required to keep an accurate record that reflects the number of hours worked at the lottery by paid workers and volunteers. Net income can be excluded if the volunteers do substantially all the work.
